It is always certain that what you sow that will be what you reap. Just as the farmer sows corn but has to fight weeds before he reaps his harvest so does the business man or woman have to "weed" their business as it grows and expands. If you sow bad customer service, less than the best products, and/or bad financial management, then you reap the rewards which are not pretty. And those items can creep into the best business just as weeds infest the garden. You as the owner/manager have to "weed" your business continually.

You must watch for employees or even yourself developing bad customer service habits. Customers are not always right but they perceive that they are most of the time. Your job is to make them happy with your product. Customer service is a term that has been taught to me as making the disgruntled customer happy without selling my company down the river. This is sometimes hard, sometimes almost impossible but always rewarding. In rare instances you may not be able to do what the customer perceives as right but you can always make sure the customer knows you have done all that your business can to reach his perception of right. Having an attitude of customer first and a happy disposition to be of service goes a long way toward helping the customer accept your solution as theirs. Always weed out anyone or anything in your business that does not work to make your customers feel good about your company.

Next, you need to use your product. Test it yourself. If you sell a certain brand then do not use another. Your customers notice what you use. This is true in the car you drive, the clothes you wear, and the food you eat. Whatever you sell or make you better make sure you use it. A quick way to lose a customer is to sell them your product and they find you use your competitor's product. This should be encouraged with your employees. Yes, it is a free country and employees just work for you but if they make a living selling your product then why in the world would they want to use a competitors. This should be a vetting as well as a weeding process.

Finally, if you do not sow sound financial management principles in your business you will reap insolvency, you will fold. Logically you would want the best, most transparent, and most ethical financial principles guiding your business. If your business revenues cover the cost of doing business and you plan to apply them to the growth of the business but are reluctant to have your books audited then that should raise a red flag. Auditors are your friend, they will keep you and your business as well as your employees protected and progressive. Auditors help you identify the problem areas and help you find the best way to guide your business. Do not be afraid of auditors or your certified public accountant. Use them to make your business better.

So as you can tell a business that sows ethical and customer oriented principles will flourish while those that do not will reap their reward. Be a business that maintains the highest degree of principles and then you will have a business that is seen by its customers as the preferred place to do business.

Make Saving Part Of Your New Year's Resolution

Recent debates about Social Security and the increasing number of employers reducing or eliminating employee pensions have underscored the need for a sound retirement plan. 

Why Do You Volunteer?

"I volunteer because I believe in the organizations mission to help."

"I volunteer to be available with a friendly ear and hand to help.....It feels great to be able to give back, especially to a child, in some small way."

"Volunteering helps me to keep life in perspective and to appreciate those in my life more. It is a reminder that life is too short."

"I wanted to volunteer because I wanted to give something back to my community. But what I have found is that I am receiving so much more than I am giving."

A **volunteer** is someone who serves in a community primarily because they choose to do so. Many serve through a non-profit organization – sometimes referred to as formal volunteering, but a significant number also serve less formally, either individually or as part of a group. Because these informal volunteers are much harder to identify, they may not be included in research and statistics on volunteering.

Beyond personal choice, a number of factors exist around individual motivation and around the rewards for doing service within the community. There is in most cases a range of opinions about the point at which this service changes from volunteering to something else.

Altruism – voluntering for the benefit of others.

Quality of life — serving community because doing service makes ones own life Included here would be the benefits people get from being with other people, staying active, and above all having a sense of the value of ourselves in society that may not be as clear in other areas of life.

Giving Back — many people have in some way benefited from the work of an organization, or more generally, and volunteer to give back.

A sense of duty — some see participation in community as a responsibility that comes with citizenship — in this case they may not describe themselves as volunteers

Religious Conviction — Many faiths hold that service to others or the community is a spiritual duty or a means of reaching higher spiritual states.

Financial — Being motivated by finances is not generally included within the definition of volunteering. Some organizations are able to pay the expenses of a volunteer, others provide what is essentially a stipend or honorarium.

Career Experience — Volunteering offers experiences that can add to career prospects and many employers value volunteering experience.

Social Reasons — Volunteering is a good way to meet a lot of different people from other walks of life and it is often easy to make new friends.


