

#### The Bessemer Chamber Hosts it's 100th Annual Meeting

The Bessemer Area Chamber of Commerce hosted their 100<sup>th</sup> Annual Meeting on February 3<sup>rd</sup>, 2022 at the Bessemer Civic Center. At least 275 guests attended as 2021 Chairman of the Board Carlton Jackson (Bessemer Fire Department) relinquished his duties to the 2022 Chairman of the Board Mitch Avery (Spire). Jackson spoke briefly about his time as chairman, emphasizing the success of the chamber even in the midst of the COVID pandemic. Attendees were given the "2021 Year in Review" flyer that highlighted the chamber's growth and productivity over the last year. After his comments, Jackson ceremoniously passed the chairman's gavel to Mitch Avery, who recognized the 2022 Board of Directors and summarized the chamber's plans for its centennial year! Each year, the chamber presents the prestigious Charles A. Long, Sr. Outstanding Civic Award to a deserving individual who has served the community in the tradition of Mr. Long. Because the 2021 Annual Meeting was held virtually, the chamber announced both the 2021 and 2022 recipients: 2021 recipient BK "Skipper" Goodwin (First Financial Bank) and 2022 recipient Dr. Cynthia Anthony (Lawson State Community College). The keynote speaker Paige Hutto (President of the Chamber of Commerce Association of Alabama) discussed the importance of a chamber of commerce and also presented the Bessemer Chamber with a commendation from Alabama Governor Kay Ivey celebrating the chamber's 100<sup>th</sup> year. Mayor Kenneth Gulley gave closing comments before chamber president LaTasha Williams adjourned the meeting. ### 2021 CHARLES A. LONG, SR OUTSTANDING CIVIC AWARD

#### Alabama Aerospace and Aviation High School Now Enrolling and Hiring By: Tira Davis, *Bham Now*

Searching for a place where aerospace education can soar? Bessemer's newest charter school, Alabama Aerospace and Aviation High School (AAAHS), is preparing to officially open August 2022. We've got the details on how to apply for a teacher's position and enroll your children in the upcoming school semester. The aviation-focused charter school will offer an immersive, industry-aligned education designed to prepare students for future aerospace and aviation careers. According to a press release, AAAHS is now enrolling students, hiring teachers, and preparing to open for the fall 2022 semester after signing a contract with the Alabama Public Charter School Commission in November 2021.

A great thing about AAAHS is that it is a free public school for students who are interested in aviation and STEM (science, technology, engineering, and mathematics). The school will serve students in grades 9-12 and will enroll an initial freshman class of approximately 130-150 students.

#### **Enrollment Is Now Open**

Has your child showed interest in STEM and aviation? The AAAHS may be a great fit for them. AAAHS's CEO Ruben Morris announced that the high school will offer multiple STEM related pathways, dual enrollment, and a college preparatory curriculum—providing high-quality learning without the high cost. Here are a few of the school's partners: Delta Tech Ops, Tuskegee University, Miles College, Alabama State University, and Alabama A&M University. AAAHS is also teaming up with UAB and Auburn Aviation to provide aerospace and science pathways for its students. #### 10 Tax Deductions Your Business Should Know About

There are many tax deductions small business owners can take to save money when they file their annual return however, new entrepreneurs (and even seasoned ones) may not be aware of all the opportunities they have to lower their tax bill. Tax deductions reduce the amount of your business's taxable income, which can save you money on your quarterly or yearly taxes. Here are 10 tax deductions your small business should know about.

#### 1. Home office

The IRS allows business owners, including self-employed freelancers and independent contractors, who utilize a home office for their business to deduct certain expenses that go into furnishing and maintaining it. The amount you can deduct will depend on the size of the home office in square footage. This space must be exclusive for business, even if it's only a section of a room that has another use.

#### 2. Startup expenses

If you're just starting your business, you can claim up to \$5,000 before the launch of your business in startup expenses. While there are a few prerequisites to consider, the costs that are usually considered tax-deductible are:

- · Training expenses.
- Travel costs for obtaining employees, suppliers, and customers.
- · Market research.
- · Advertising expenses.
- · Wages for contractors or consultants.

#### 3. Repairs and maintenance

If you have a brick-and-mortar store, you may find repairs and maintenance are necessary as the building ages. You can deduct repair and maintenance costs that are necessary to keep the building in working, ordinary order. Examples may include painting the exterior or interior of the building and sealing leaks or cracks. It's important to note that these repairs must be solely to maintain the building rather than improving such as adding a new room, which is not taxdeductible.

#### 4. Business insurance

Depending on your state, the majority of businesses are required to carry a few forms of business insurance, such as worker's compensation insurance, general liability insurance and professional liability insurance. Each of these insurance forms is considered necessary for a business's operation and can be deducted from your taxable income.

#### 5. Advertising and marketing

The IRS considers any costs relating to advertising and marketing to be tax-deductible. This includes billboard promotion, online advertising, and the cost of producing advertising materials, such as business cards or logos and more.

#### 6. Employee salaries

All of your employees' wages are also considered fully deductible, including any bonuses and commissions, as long as the payments are deemed ordinary, reasonable and for services rendered. This deduction can also apply to independent contractors; however, they must be classified correctly to avoid penalties.

#### 7. Charitable contributions

If your business has made a donation to charity, you may be able to claim it on your tax return. The contribution must be a cash donation and benefit a qualified charitable organization, such as a religious organization or a nonprofit founded in the United States. If the business is an LLC, sole proprietorship or partnership, these charitable contributions must be claimed on personal income tax forms.

#### 8. 'Bad debt'

A "bad debt" is defined by the IRS as a loss of a debt that occurred through the business or one that was closely related to your trade or business. This includes instances where you may have loaned money to an employee, vendor or customer and did not see a return. You must prove that the debt was related to the business and not a personal debt.

#### 9. Business vehicle

Expenses from the usage of a company or business vehicle are usually seen as 100% deductible, such as tolls, maintenance fees, licenses, insurance and more; however, it's vital to keep detailed records of how the business is using the car, including tracking the mileage. Additionally, the costs must be divided based on mileage if you also rely on the vehicle for personal use.

#### 10. Business entertainment

The events and meals you provide your employees and potential customers or vendors can also be tax-deductible. The amount you can claim depends. For example:

- Employee office parties are 100% deductible.
- Meals and snacks for employees at the office are 50% deductible.
- A business dinner with a client is 50% deductible.





All ambassadors MUST make every effort to meet the minimum expectations in order to participate in the ambassador program.

In order to serve as an ambassador, you or your company must be an active member of the Bessemer Area Chamber of Commerce. There will be a 90-day trial period to allow individuals time to consider their decision. If an Ambassador has been inactive (without contacting the chamber or the Ambassador coordinator) for a period of 60 days the coordinator will contact them, regarding their future in the program, after 90 days they will be deleted from the current ambassador group. 
